The processing of your personal data will take place at the headquarters of the Data Controller located in registered office in Modugno (BA), S.P. 231 km 1.110 - c.a.p. 70026 and will be done using automated and manual methods and tools to ensure maximum security and confidentiality, by specifically authorized parties as long as is strictly necessary to attain the purposes for which they were collected. The data provided will be used with paper-based, computerized and telematic tools. Specific security measures are complied to prevent data loss, illicit or incorrect use and unauthorized access. Once the above storage terms have elapsed, the data will be destroyed or be anonymized through the technical cancellation and backup procedures.

	<p><b>NATURE OF THE PROVISION AND REFUSAL</b></p> <p>The provision of personal data is mandatory for the conclusion and performance of the contract, as well as for the fulfillment of ex lege obligations and, therefore, any refusal, even partial, or the inaccurate indication of such data determines the impossibility for the Data Controller to properly perform the contract and/or all related obligations.</p>

### AUTHORIZED PARTIES

The personal data collected will also be processed by authorized internal parties acting on the basis of specific instructions provided for the purposes and methods of the processing.



### RIGHTS OF THE DATA SUBJECTS – COMPLAINT TO THE INSPECTION AUTHORITY

In relation to the data undergoing processing mentioned in this document, it is your right to:

- ask the Data Collector for access to your personal data and information related (GDPR Article 15) at any time; the correction of inaccurate data or the integration of incomplete data (GDPR Article 16); the erasure of your personal data (upon the occurrence of one of the conditions indicated in GDPR Article 17, paragraph 1 and in the respect for the exceptions provided for in paragraph 3 of the same article); the restriction of the processing of your personal data (upon the occurrence of the hypotheses indicated in GDPR Article 18, paragraph 1);
- ask to the Data Controller and obtain - in the cases in which the legal basis of the processing is the contract or consent, and it is carried out by automated means - your personal data in a structured and machine-readable format, also for the purpose of communicate such data to another Data Controller (so-called right to the portability of personal data - GDPR Article 20) at any time;
- object to the processing of your personal data to the occurrence of particular situations that affect you (GDPR Article 21) at any time.

If you believe that the processing of your data is in violation of the Regulation terms, you can lodge a complaint with a supervisory authority (Authority for the protection of personal data - [www.garanteprivacy.it](http://www.garanteprivacy.it)), as provided for by GDPR Art. 77, or refer the matter to appropriate legal courts (GDPR Article 79).
